**15 DAY NOTICE OF MODIFICATIONS TO TEXT
OF PROPOSED REGULATION
PRINCIPALLY AT-FAULT REGULATION**

On October 15, 2010, Insurance Commissioner Steve Poizner issued a Notice of Proposed Regulatory Action to adopt regulations amending California Code of Regulations (CCR), Title 10, Chapter 5, Subchapter 4.7, Article 4, Section 2632.13 and adding California Code of Regulations (CCR), Title 10, Chapter 5, Subchapter 4.7, Article 4, Section 2632.13.1. The Department held a public hearing on November 29, 2010 and received written and oral public comments in response to the Notice.

PUBLIC COMMENT INVITED

The Commissioner plans to make changes to proposed Section 2632.13, shown in the attached Revised Proposed Text of the Regulation. Accordingly, pursuant to the provisions of California Government Code Section 11346.8(c), the Commissioner is soliciting written public comments on these changes only. Comments submitted on unchanged portions will not be considered. A copy of the changes will be available for public comment for at least 15 days. By appointment with the contact person listed below, the proposed changes may be inspected between 9:00 a.m. and 4:00 p.m., Monday through Friday at the Department's offices at 300 Capitol Mall, 17th Floor, Sacramento, California 95814.
