# **AB 5**

Title:	Employers: Opportunity To Work Act
Location:	Assembly Appropriations Committee
Disposition:	Pending
Summary:	Creates the Opportunity to Work Act. Requires certain employers to offer additional hours of work to an existing nonexempt employee before hiring an additional employee or subcontractor, to post a notice of employee rights, and to maintain certain documentation. Authorizes certain civil actions for remedies.

Location:	Vetoed
Disposition:	Vetoed
Summary:	Amends the Brady Jared Teen Driver Safety Act. Expands the scope of a provisional licensing program by extending the age range. Exempts from the program a person less than a specified age who possesses an ambulance driver certificate or a commercial driver's license. Authorizes the department to impose certain fees to driver schools. Prohibits a driving school from charging an applicant a fee for a certificate of completion that exceeds the fee the department charges the school.

Location:	Assembly Communications and Conveyance Committee
Disposition:	1/11/2018: Do pass and to Appropriations Committee
Summary:	Requires the Department of Motor Vehicles to adopt application requirements for the testing of autonomous vehicles on public roads without the presence of a driver inside. Requires that the manufacturer certify that the local authorities within the jurisdiction where the autonomous vehicle will be tested have been provided with a written notification. Requires that the manufacturer provide certain law enforcement agencies with a copy of a law enforcement interaction plan.

Title:	Workers Compensation: Employees

Disposition:	Held in Committee
Summary:	Relates to the worker's compensation system. Specifies that the definition of employee applies without regard to immigration status. Removes an exclusion for an employee who was employed, or was contracted to be employed, for less than a specified amount of hours.

Title:	Personal Information: Privacy: State and Local Breach
Location:	Assembly Appropriations Committee
Disposition:	Held in Committee
Summary:	Relates to state and local breaches of privacy. Requires a state or local agency, if it was the source of a computer breach of information, to provide appropriate identity theft prevention and mitigation services at no cost to a person whose personal information, including social security number, driver license or identification card number.

Location:	Assembly Appropriations Committee
Disposition:	Pending
Summary:	Extends the time for payment for the fire prevention fee charged on each habitable structure within a state responsibility area. Establishes the Fire Prevention Fee Amnesty Program to be administered by the State Board of Equalization. Provides for specified requirements for eligibility, including the filing of an application under penalty of perjury. Require the state board to waive all penalties and interest for the specified fee reporting period for which the fire prevention fee amnesty is allowed.

**Summary:** Authorizes the City of San Jose and the City and County of San Francisco to implement a pilot program utilizing an automated speed enforcement system for speed limit enforcement on certain streets. Provides that a speed violation that is recorded by an ASE system is subject to a specified civil penalty.

Summary:	Makes technical, nonsubstantive changes to provisions of existing law defining surety insurance.

Disposition:	Pending
Summary:	Relates to an autonomous vehicles pilot project in Contra Costa County. Extends the authorization for the pilot project to after the operative date of regulations promulgated by the department.

Title:	Fraternal Fire Insurers: Coverage

Disposition:	Enacted
Chapter:	2017-190
Summary:	Amends existing law which authorizes certain nontraditional insurers to insure against specified risks, and insure against a specified list of losses. Removes insuring vehicles owned or operated by the insured or by any tenant of certain premises from the list of insurable losses and adds insuring against liability to the list of insurable losses. Deletes a certain prohibition.

Disposition:	Pending
Summary:	Expands the Forest Fire Prevention Pilot Project Exemption of the Forest Practices Act to allow the construction or reconstruction of temporary roads on certain slopes if certain conditions are met, including that a registered professional forester designates temporary road and landing locations, certain watercourse crossings, unstable areas, and connected headwall swales, including convergent slopes. Requires the review of the tends in the use of, compliance with, and effectiveness of the exemption.

<b>Disposition:</b>	Enacted
Chapter:	2017-404
Summary:	Makes it unlawful for a person to operate an unmanned aircraft in pest control unless the pilot holds a valid manned or unmanned pest control aircraft pilot's certificate issued by the director and is certified by the Federal Aviation Administration to conduct pest control. Requires a pilot to be certified by the State Department of Public Health as a vector control technician to be eligible for an unmanned pest control aircraft pilot's certificate under the status of vector control technician.

Summary:	Requires certain admitted insurers to report specified information through a data call. Requires the Insurance Commissioner to convene a task force to increase investment by insurers in low- to moderate-income communities. Establishes a tax credit to be given to insurance company investors for a qualified investment made in a community development financial institution.

Summary:	Requires an insurer to with premiums in excess of a specified amount to add veteran and lesbian, gay, bisexual, and transgender (LGBT) business enterprises to the entities for which reporting is required. Requires a public report on diversity in procurement efforts. Authorizes the Insurance Commissioner to initiate a data call related to specified subjects.

Summary:	Requires the operator of an autonomous vehicle who is involved in an accident that results in damage to the property of any one person in excess of a specified amount, or in bodily injury, or in the death of a person, to report the accident to the Department of Motor Vehicles. Requires a traffic collision report prepared by a member of the Department of the California Highway Patrol or any other peace officer to specify if an autonomous vehicle was involved in the traffic collision in any manner.

Summary:	Specifies that an association may not establish a general policy prohibiting the installation or use of a rooftop solar energy system for household purposes on the roof of the building in which the owner resides, or a garage or carport adjacent to the building that has been assigned to the owner for exclusive use. Requires an association, when reviewing a request to install a solar energy system on a multifamily common area roof shared by more than one homeowner, to require certain things from an applicant.

Summary:	Extends the repeal date of provisions authorizing the Department of Transportation to conduct testing of technologies that enable drivers to safely operate motor vehicles with less than 100 feet between each vehicle or combination of vehicles. Prohibits a person from operating a motor vehicle participating in this testing unless the person holds a valid driver's license of the appropriate class for the participating vehicle.

Requires the vehicle owner to use an alternative renewal method if he or she does not provide the department with the required additional information.

Requires priority for the tax credit to be given to insurance company investors over all other tax credit investors.
