On June 21, 2013 the California Insurance Commissioner published Notice of Proposed Action and Notice of Public Hearing concerning proposed regulations: Hazardous Financial Conditions and Corrective Actions. The commissioner held a public hearing on August 7, 2013 and received written and oral comments in connection with the proposed regulations. In response to comments received, the commissioner amended the originally noticed text, and on September 23, 2013 the commissioner provided notice and solicited comments about revisions to the proposed regulations.

The commissioner has made additional amendments. Specifically, the commissioner amended 2598.3(b) and (c) in order to clarify the process.

#### PUBLIC COMMENT INVITED

The commissioner solicits written comments only on the amended text of 2598.3(b) and (c). Additions to the September 23 noticed text are indicated in <u>underline</u> format; deletions are indicated in <u>strikethrough</u> format.

Comments submitted on unchanged portions of the text will not be considered.

The commissioner believes the changes made are nonsubstantial, are solely grammatical in nature or are sufficiently related to the original text that the public was adequately placed on notice that the change could result from the originally proposed regulatory action.
