NOTICE OF AVAILABILITY OF REVISED TEXT

On August 11, 2006 California Insurance Commissioner John Garamendi issued a Notice of Proposed Action, proposing the amendment of Title 10, California Code of Regulations, Chapter 5, Subchapter 7.6 Sections 2696.1 through 2696.10 Insurance Mediation Program. The proposed amendments will add automobile collision and physical damage disputes to the Department's mediation program. The proposed amendments will also update the regulations to include definitions of new terms, delete certain procedural sections and clarify existing procedures.

Pursuant to the requirements of Government Code section 113646.8(c) the California Department of Insurance is providing notice of changes made to the proposed **RH03030123 Proposed Amendments to the Insurance Mediation Program** which were the subject of a regulatory hearing on October 10, 2006. These changes are in response to comments received regarding the proposed action.

PUBLIC COMMENT INVITED:

The Commissioner has made changes to Section 2696.2 by adding two new subparagraphs (m) and (n) and now solicits written comments on those changes only. The Commissioner believes the changes made are sufficiently related to the original text that the public was adequately placed on notice that the change could result from the originally proposed regulatory action. Accordingly, pursuant to the provisions of California Government Code section 11346.8(c), the Commissioner is soliciting written public comment on these changes only. Comments submitted on unchanged portions of the proposed regulations will not be considered.

A copy of the proposed sections to be revised with the proposed changes clearly indicated will be available for public comment and inspection for at least 15 days before the proposed action is adopted. Additions to the proposed amendments are denoted by BOLD and DOUBLE UNDERLINE.
