NOTICE OF AMENDMENT OF TEXT OF REGULATION

STANDARDS FOR REPAIR AND USE OF AFTERMARKET PARTS

DATE: October 9, 2012

CDI REGULATION FILE: REG-2011-00024

On June 21, 2012, California Insurance Commissioner Dave Jones issued a Notice of Proposed Action, proposing the adoption of regulations governing standards for auto body repair and the use of aftermarket parts. The proposed regulations amend Article 1 to be set forth in Title 10, Chapter 5, Subchapter 7.5 of the California Code of Regulations (“CCR”). The Department held a public hearing on August 9, 2012 and received written and oral public comments in response to the Notice. The Department is now proposing changes to the originally noticed text.

PUBLIC COMMENT INVITED:

The Commissioner plans to make changes to the proposed text of Sections 2695.8(f) and (g), and now solicits written comments on those changes only. The Commissioner believes the changes made are sufficiently related to the original text that the public was adequately placed on notice that the changes could result from the originally proposed regulatory action. Accordingly, pursuant to the provisions of California Government Code Section 11346.8(c), the Commissioner is soliciting written public comment on these changes. Additionally, amendments that are nonsubstantial or solely grammatical in nature have also been made to Section 2695.8(f) and (g).

A copy of the proposed text to be revised, with the proposed changes clearly indicated, will be available for public comment and inspection for at least 15 days before the proposed action is adopted. Deletions are indicated in double strikethrough; additions are double underlined. This document may be inspected between the hours of 9:00 a.m. and 4:00 p.m., by arrangement with the contact person listed below, at the Department’s offices at 45 Fremont Street, 21st Floor, San Francisco, California 94105.
