## NOTICE OF INFORMAL WORKSHOP REGARDING PRINCIPALLY AT-FAULT REGULATIONS SET FORTH IN TITLE 10, CALIFORNIA CODE OF REGULATIONS, SECTION 2632.13

The California Department of Insurance ("Department") invites all interested persons to attend an informal workshop to discuss the principally at-fault regulations set forth in Title 10, California Code of Regulations, Section 2632.13, filed with the Secretary of State on 10-4-2004, and operative on 11-3-2004 and good driver discount policy regulations set forth in Title 10, California Code of Regulations, Section 2632.19, filed with the Secretary of State on 10-5-98, and operative on 11-4-98. The Department is considering the following amendments to the regulations:

- For section 2632.13: restoring text to subsection (c) that existed prior to the Change Without Regulatory Effect amending subsection (c) and Note filed 12-5-2002: "a driver may be considered to be principally at fault in an accident if the driver's actions or omissions were at least 51 percent of the proximate cause of the accident, subject to the exceptions set forth in Subsection (d), and, in accidents not resulting in death, if the total loss or damage to the property of any one person caused by the accident exceeded \$750.00;"
- For section 2632.13, clarifying the treatment of solo accidents with respect to the \$750 threshold described in subsection (c)
- For section 2632.13, clarifying the obligations of subsequent insurers under subsections (f), (g), and (i)
- For section 2632.19, changing the last sentence in subsection (d) to conform to the \$750 threshold of SB 1590 (Approved by Governor September 20, 2002. Filed with Secretary of State September 21, 2002.): "In bodily injury accidents not resulting in death, the total loss or damage caused by the accident must exceed \$500,750.00"
