Re: SB 332 (Dodd) Civil liability: prescribed burning operations: gross negligence, as amended May 24, 2021.

PIFC Position: Support

The Personal Insurance Federation of California (PIFC) is a statewide trade association that represents seven of the nation's largest property and casualty insurance companies including (State Farm, Farmers, Liberty Mutual Insurance, Progressive, Mercury, Nationwide and Allstate as well as associate members CHUBB, CONNECT by American Family Insurance, and NAMIC) who collectively write the majority of personal lines auto and home insurance in California.

Based upon the most recent (May 24, 2021) version of the bill, which now limits the extension of immunity for damages caused by negligent prescribed burns only to fire suppression, rescue or emergency medical services, fire investigation, and other related costs that would otherwise be recoverable pursuant to Sections 13009 and 13009.1 of the Health and Safety Code, ***PIFC withdraws our opposition and is now in support of SB 332.***

Prescribed burning is the controlled application of fire to the land to reduce wildfire hazards, clear downed trees, control plant diseases, improve rangeland and wildlife habitats, and restore natural ecosystems. As catastrophic wildfires continue to be a growing concern in California, the use of prescribed burning to reduce hazardous fuels is an important tool that can help reduce risk, loss, and property damage.

PIFC has long supported legislation that would reduce the risk of catastrophic wildfires across California. Since the new normal of California's devastating wildfire seasons over the last four years, the insurance industry has been working diligently to help customers rebuild their homes, replace their personal property, and restore their lives. The increased use of prescribed fire not only protects lives and property, it also creates habitat and assists in the regeneration of certain species of plants and trees.

Prescribed burns are an inherently dangerous activity. Ensuring that safety standards are met and that there is appropriate legal accountability for people performing controlled burns is the right approach. SB 332 strikes a reasonable balance to increase the use of prescribed burns to reduce risk and loss from wildfires and maintain the existing right to remedy for those who have been
